With the final decision of creating fissures in the Indian subcontinent in 1947, Indian history got marred by cries of political and human agony. Not only did Indian subcontinent attain independence from British rule, it also got divided on the basis of religious differences once the idea of creating a separate all-Muslim nation-state came into being. The Partition uprooted millions of people and rendered them homeless. The resulting migrations and displacements ruptured their sense of identity which was once fabricated around their geographical markers of identity like trees, rivers, lakes, and cultural traditions and practices. The identity crisis changed how a society once felt and thought. The impact of distancing people from their roots on their individual identity has since been devastating. The purpose of this work is to focus on literature as a site of historical documentation. Partition literature is mostly governed by narratives of chaos, violence and loss. The historic episode of the Partition has been captured in its varied aspects by a number of writers across different genres. The present study focuses on the representations of the impact of various political decisions on society in Indian and Pakistani short stories. The personal narratives of the Partition survivors documented in this research work are bold and far from the politically-correct narratives of this part of Indian history. Their interviews serve to present the real human pain and misery which simultaneously celebrate the triumph of human resilience and perseverance. Both short stories and personal narratives are different platforms but hold a common purpose of bringing to the fore the brutal impact of the events of the Partition and the lived reality in the form of traumatic experiences of the Partition survivors.

Emergence of the Khasi Public Sphere and the Consolidation of Identity.

Khasi Press in 1896, was preceded by a tumultuous era of empire building by the East India Company and then the British crown, and concerted efforts by different Christian dominations. Though these two organisations operated on different tangents, Mills' report of 1854 brought them closer to each other. Together they brought about marked changes in the communities, in terms of both geography and administration. The shifts in these fields had wider implications on the society in terms of language, religion and representation which affected and produced the Khasi Public Sphere. One of the ways this was accomplished was through the imposition of an education policy promoting the use of English and later the vernacular. Literary productions were an important tool not only to mould public opinion but became a reflection of a political shift in the Khasi community as is evident from the gradual growth in terms of literary mediums employed, and content used, in the large number of newspapers and periodicals that erupted in the beginning of the twentieth century. The political ethos and change is clearly reflected in the sheer number of papers and periodicals that emerged between 1896 and 1971, along with the formation of various organisations. Besides historical records and reports, letters, prefaces and periodicals are focused on to determine the existence of a coterie of participants responsible not only for the genesis of the public sphere but ensured its continuity. A study of the Khasi public sphere needs to be understood against the colonial backdrop in which it operated. This is not the conventional sphere of Habermas' conception because the context in which it operated and the systems under which it was created were markedly different.

'Menstruation as such is not positively valued...Since menstruation is such a politically charged area, various kinds of discourse around the subject have emereged over the last few years in and around the women's liberation movement' (Laws 4). Understanding the politics of linguistic Taboofication of menstruation can help in finding ways to address the negativity associated with menstruation and women's body; desexualizing it and looking at it from a de-stigmatized point of view. This work has tried to help one understand the psychology behind the creation of a 'taboo avoidance technique'; taking into consideration 'euphemisms' and other verbal taboo language, study of which are relatively scarce as compared to the study of metaphors and metonymy.

Among the Tamil literary anthologies, Cankam literatures are the most ancient ones. The Cankam literature is comprised of Ettuttokaiand Pattuppāţţu. There are 2381 poetries in the 18 books. According to the subject matter and grammatical rules these are further classified as Akam and Puram. There are 1863 Akam poetries. By the following methods the meaning of these poetries is understood: Ullurai, iraicci, kurippup porul, kurittukkāttal, and kurippu. The introduction of modern western literary principles particularly semiotics, explored the poetries and revealed deep meaning hidden into these creative work. Symbolism is the field of language which sees literature, society, and historical arts as a symbol, as well as a linguistic entity and explores its meaning. Moreover, this has been a part of linguistics and has developed into a separate field today. Semiology, whichevolved from the thinking of linguists Bernard Saussure and Charles Saunders Pierce in the early 2100, and has had an impact on many fields. This is because symbolism is more in poetic form of literature. In continuation of this nowadays there are more articles and books are being published in Tamil related to this field. This theory draws more meaning from the Cankam poetry. When the meaning of Akam poetry deepens it produces alternative texts. Semiology is the doctrine of signs and it originated in the West as a multidisciplinary thinking system. Saussure used two terms, Langue(language) and parole(speaking) to explain the structure of language. Stating that the language was comprised of words he revealed the internal elements inside a word. He further stated that these are not natural but developed according to the social customs. He established that the meaning(signified) of a word(signifier) was symbolic And also Roland Barthes concept of first level meaning and multiple level meaning is also taken into consideration in this study.

Literature Women's Issue and Socio Cultural Concerns: A Comparative Study of Memories of Selected Indian Writers.

The thesis titled "Literature, Women's Issues and Socio-Cultural concerns: A Comparative Study of Memoirs of Selected Indian Woman Writers," is a study of how the diversity in the social, cultural and historical backgrounds of women affect their lives and shape their personalities. This project follows a descriptive and analytical approach to study the memoirs of some selected Indian women. As a methodology, the principal method that has been followed in this research is a comparative study of the primary texts. During the nineteenth and twentieth centuries, several memoirs have been written by women in India. The four primary texts which I have selected for this research include - Memoirs of an Indian Woman by Shudha Mazumdar (1989), A Princess Remembers by Gayatri Devi (1995), First Darling of the Morning by Thrity Umrigar (2004) and Climbing The Mango Trees by Madhur Jaffrey (2006). While the comparative study of the four primary texts brings out the differences in their sociocultural backgrounds, they also exhibit some common feminist attributes. However, the Western term 'feminism' cannot be blindly applied to these memoirs. Keeping in mind the Indian milieu, the memoirs demand a different kind of inquiry and offer new dimensions to feminism which has been deliberated upon in the conclusion of this thesis. The broad objectives of this thesis are as follows: 1. To discuss the various dimensions of memoir writing. 2. To critically analyse the four primary texts keeping in mind their social, historical and cultural backgrounds. 3. To undertake a comparative study of all the four primary texts. 4. To review the texts with particular significance to re-visiting feminism in the Indian context. The thesis has been broadly divided into six chapters which include introduction, an individual chapter on each of the primary texts and Conclusion. It also includes an extensive bibliography.
