Ahmad Mehmoud is an Iranian novelist of 19th and 20th Century that have significant works in both novel and short stories. His real name was Ahmad Ata. He was born in 1931 in Ahvaz (Iran). Inhis youth, he worked as a day labourer, driver, construction worker andsuffering imprisonment for leftist political views and oppositionistactivities, because he was also a communist. Ahmad Mehmoud had arealist style of writing and was essentially a technical author. He was also amember of "Kanoon-e-Nevisandegan-eiran" and his first storyappeared in omid-e-iran magazine, and in 1959, Ahmad Mehmoud beganpublishing collections of stories with Mul (The Paramour) his last bookwon the "Golshiri's Book Prize" in 2001 and garnered much acclaim. Inmemory of his brother who died in the Iran-Iraq War, he wrote "Thescorched Earth". Ahmad Mehmoud died of respiratory failure in Tehranat the age of 71 in 2002. He was a novelist but, he is known as a realistwriter of Iran.Realist authors chose to depict everyday and banal activities and experiences, instead of using a romantisized or similarly stylized presentation. Realism is a movement in literature was based on "object reality" and focused on showing everyday a quotidian activities and life,3primarily among the middle or lower-class society, without romanticidealization or dramatization. Realism is a technique in the literature, italso denotes a Particular kind of subject matter, especially therepresentation of middle-class life. Ahmad Mehmoud is of stylist novelists that have significant workin both novel and short story, localism and creating stories with politicaland social themes are characters of his works. He wrote 6 Novels and ashort stories collections.My research consists of textual analysis of Ahmad Mehmoud'swork in the context of Realism. Furthermore, I have discussed his style of writing, in particular in the context of realism. The dominant point ofview is omniscient narrative in Mehmoud work and characterization inhis stories formed through actions and words of the characters in thestory.
